

**INTERNATIONAL STUDENT ACCOMMODATION AGREEMENT  
LIVING WITH A PARENT – 2020/2021**

1. I understand that the School requires me to live with my daughter while she is in New Zealand and that I must not leave without notifying the School. If I wish the accommodation arrangement to change, I must discuss it with the Accommodation Co-Ordinator at least two (2) weeks in advance. I understand that under New Zealand law I am unable to leave her unsupervised if under fourteen (14) years old.
2. I must send the School a copy of my Visitor Visa prior to my daughter's enrolment. I must send the School an updated copy for every year of my daughter's enrolment while I live with her in New Zealand.
3. My NZ address must not be further than 5kms from the School unless prior approval has been given by the School.
4. I will communicate with the School about any matter which may affect the School's ability to carry out its responsibilities. This includes but is not limited to changes of address, phone numbers, and change of visa type.
5. I understand that should my daughter be granted domestic student rights due to a change in my visa status, it will be necessary to re-apply for her enrolment to the School as a home zone student. I must follow the usual home zone application process to provide evidence of domestic status and residence in the home zone. I understand there is no direct transition from International Student to home zone student and that continued enrolment is not guaranteed unless I meet the home zone criteria and successfully complete the application process.
6. I understand that the School cannot be responsible for proving our living costs to Immigration New Zealand.
7. I understand that the School is not responsible for assisting me or my daughter with applying for a Visa.
8. I understand that the School is not responsible for airport transfers for myself, my daughter or other family members.
9. I agree that should I need to leave the country, I must notify the International Department immediately and provide the contact details of the alternative accommodation and caregiver for my daughter. I understand the alternative accommodation and caregiver requires the School's prior approval.
10. I agree to abide by the conditions on my visa during my stay in New Zealand.
